SAVING GRACE - A GUIDE TO Financial Well-Being

We are excited to have available a new Biblically based, Wesleyan tool that helps participants reach financial well-being goals.

Saving Grace: A Guide to Financial Well-Being is a program to help people of faith create healthy relationships with money and possessions. Participants will move through six sessions covering such topics as saving, earning, giving, spending, and debt, along with helpful strategies for achieving a sustainable financial life. Adapted from the best-selling Freed Up Financial Living from the Good Sense Movement, this study is based on Wesleyan values and provides text and tools to help participants address life concerns and reach personal financial goals.

ENDOWMENT MAKES A DIFFERENCE IN THE LIVES OF THE CHURCH, COMMUNITY, AND WORLD



White Bear Lake United Methodist Church has had an endowment fund since 2008. One member who always felt the church should have an endowment fund left assets to the church to establish it. Two years later, a couple left their estate to the church which was added to the existing endowment fund. The Minnesota Methodist Foundation was great to work with in establishing the charter and the distribution guidelines. The money is in socially responsible investments, and the distribution guidelines specify that the money can't be used for items that should be part of the regular annual budget.

Each year the church takes a distribution of between 4-5% of the prior year's average endowment fund balance. This ensures that the endowment fund can continue without running out of money.

The Endowment Fund has funded some exciting projects over the years. In 2018, funds were used to upgrade the sound system in Fellowship Hall to make it easier to have events there so everyone could hear the speaker. We used funds to replace the Automated Defibrillator unit, to buy table racks to make moving and setting up tables easier for custodians, for security upgrades including parking lot and building LED lighting, security cameras, keyless entrance system on doors, and computer system upgrades to support the systems. It funded 10 scholarships to Good Earth Camp for church youth who still talk about how meaningful the experience was.

The Endowment fund has supported Century College in White Bear Lake and made a large positive impact for many students. We distributed gas cards and Target & Cub Foods gift cards so students in need could get to school and buy essentials. We provided a scholarship to a nursing student and funded a trip for two students to go on a Black Girls Advocate College trip to explore colleges and meet with other black students.

This year, we used the Endowment to fund the Racial Justice Initiative and will support a Black History Month recital in 2023. For Missions, we have provided money to Common Hope to support students and families during the pandemic, and helped fund a new secondary school in Haiti.

The church is very fortunate to have an Endowment Fund that allows us to make a difference in the lives of people in our own church, community and around the world.

An endowment is a great way to provide funding for the ministries of your church. We are thankful to White Bear Lake UMC for sharing their endowment impact story.

USING THE 16-OUARTER ROLLING AVERAGE BALANCE METHOD TO DETERMINE FUNDING AMOUNTS

When visiting with church finance and investment committees we often talk about the advantages of using a 16-quarter rolling average balance to determine an amount available for ministry. The average balance method involves treating the investment as a type of endowment referred to as a quasi-endowment. Determining an annual distribution based on an average balance helps with budgeting, assists in growing the principal investment and assures that ministries will be funded in years of market gains as well as in years of poor market performance.

Here are the basic steps to using the quasi-endowment method:

- Create or modify a current spending policy to include an annual distribution rate along with other information that will guide the administration of the fund. Distribution rates are commonly set between 4%-5%. The Dakotas and Minnesota Methodist Foundations use a 4 1/2% distribution rate.
- 2. Calculate the 16-quarter average balance. This is typically done at the end of each year using the previous four full years of quarterly balances. For example, the 16-quarter balances from 2019-2022 are used to calculate the average balance for 2023. In the next year, a new average balance would be calculated using numbers from 2020-2023.
- 3. Multiply the average balance by the determined spending rate to find the annual amount available to distribute.

Treating an investment account as a quasi-endowment helps fund ministry in the following ways:

- Budgeting for ministry becomes easier because the distribution amount will be relatively equal year over year.
- Using a rolling average balance and constant distribution rate helps protect and grow the principal over time because any market gain above the distribution rate will be reinvested in the fund. And, as the principal grows, the amount available each year will increase.
 Using an average balance calculated over four years helps to smooth market volatility and makes it possible to distrib-
- ute funds even in years of market decline.

KLINGBEIL GRANTS ARE BACK FOR 2022 FOR DAKOTAS CHURCHES

The Dakotas Methodist Foundation is again offering the Klingbeil Grants for churches in the Dakotas who open a new investment or endowment account between July 1 - December 31, 2022.

Klingbeil Investors Grant: Churches that establish a new investment account with the Foundation from July 1 - December 31, 2022 will receive an annual grant of 2% of their initial deposit for the three years following their initial investment. This grant applies only to the first \$75,000 invested. The grant will be forfeited if the church closes the account before the end of the third year. The principle must remain invested for the full three years and earnings are available after one year. For example: A church invests \$50,000 in a new investment account. At the end of each year, for three years, \$1,000 will be deposited in the church's account. After three years, \$3,000 will have been deposited in the account, plus interest.

Investment Accounts take advantage of the Foundation's investment power to provide more funds for the ministries of your church. You have access to the funds after one year of the initial investment.

Klingbeil Legacy Grant: Churches that establish a new endowment fund with the Foundation from July 1 - December 31, 2022 will receive an instant grant of 10% of the amount invested. For example: A church that establishes an endowment of \$50,000 would receive an instant grant of \$5,000 to bring the principal up to \$55,000. An endowment of that size will typically generate about \$2,500 annually. This grant will only apply to the first \$250,000 of an endowment for a maximum of a \$25,000 grant.

Endowments keep the principal amount intact forever but allow you to use the investment income for the ministries of your church.

KORONIS MINISTRIES DEDICATES NEW TABERNACLE

September 10, 2022 was a day of celebration at Koronis Ministries. Not only did they celebrate 100 years of ministry on Lake Koronis, but they also dedicated the brand new Tabernacle.

This project has been many years in the making. The old Tabernacle was torn down in the spring of 2015 after nearly a century of use, and the new one was scheduled to be completed in 2017. Due to many delays, rising costs, and the pandemic, construction on the new building finally began in June 2021.

The new Tabernacle houses an upper-level meeting room overlooking the lake with a capacity of nearly 300, and a lower-level dining room that can comfortably seat well in excess of 200 guests. This new Tabernacle honors the cherished memories and features of the original structure while better meeting the needs of future generations with amenities that the original structure lacked—like air conditioning, heat, restrooms, improved lighting, and advanced technological capabilities.

Thousands of lives have been changed over the 100 years that Koronis Ministries has been doing ministry. The new Tabernacle will continue to provide a sacred space for where people of all ages can sense God's call and committ their lives to Christ.
